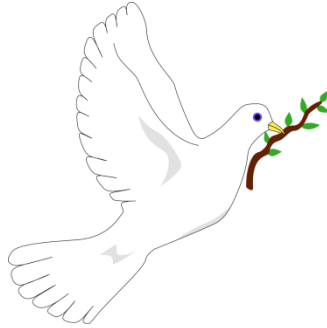

### **Resident Admission Criteria**

1. Applicants must be free of all mood altering substances.
2. All applicants must be ambulatory and able to take appropriate action in the event of an emergency.
3. All applicants are required to be at least 18 years of age.
4. All applicants must be able to converse in the English language (we have no current residents available to assist other languages).
5. All applicants must be willing to attend all in-house mandatory Bible studies and prayer meetings.
6. All applicants must adhere to and sign our Rules and Regulations Agreement.

### **Rules and Regulation Agreement**

All applicants agreeing to the terms within this agreement will submit to a drug test prior to being admitted into Agape House, as well as random testing. Rent is \$180.00 per week and is to be paid by Friday to the General Manager or Property manager. You are required to pay your first 2 weeks, plus an assessment fee totaling \$450.00 upon admission to the house. Failure to follow the rules of the house could result in an immediate removal from the residence. The rules are in place to create a safe and structured environment conducive to living a clean and productive life and are in the best interest of all residents.

1. During the first 2 weeks at the house, you will be in your orientation phase. This is a period of time that you are not permitted to leave the house unless you are with a senior house resident, or approved by the House Manager.
2. No drugs or alcohol are permitted, doing so will result in immediate removal from the residence.
3. There will be NO smoking in the house. You will have a designated area outside, which must be kept clean at all times.
4. You are required to attend in-house meetings, including Bible study and prayer groups, as well as maintain a home church for weekly attendance.
5. No adult males are permitted in the residence.
6. All visitors are required to remain in common areas.
7. No overnight visitors permitted.
8. Any request for an overnight pass must be submitted to the House manager 48 hours prior to the day of overnight.  
NO EXCEPTIONS!
9. A curfew will be in place for all residents of 11 pm Sunday-Thursday, 1 am Friday & Saturday unless you are working or have an exception approved by the House Manager.

10. All residents will have house chores, required to be completed daily, assigned by the House Manager weekly, on a rotating basis.
11. All residents are required to keep their room clean and orderly.
12. No one is authorized to hang anything on any walls that requires nails or tape; you may use removable hooks only.
13. All residents will sign-in and out of the house. A sheet will be provided in the common area on the first floor.
14. Any sexual harassment, threats of violence, physical altercation or theft will be an immediate removal from the residence and/or criminal charges will be filed.
15. Any damages to the property will result in restitution and/or criminal charges will be filed.

You are responsible financially to pay your rent on time, failure to do so will result in removal from the property. This is not a legal lease agreement, but a temporary living agreement. At no time do you have rights as a renter; at any time or for any reason the property owners reserve this right to end this agreement.

Agape House owners and management are not responsible for any personal belongings, including medication of the residents. Please keep your items secured at all times. Upon leaving, each resident will have 7 days to retrieve their belongings.
